BY THE COMMISSION:

By application filed October 25, 2012, Citizens Telecommunications Company of Nebraska d/b/a Frontier Communications of Nebraska (Citizens), of Rochester, New York, seeks approval of an Amendment to its Interconnection Agreement with Nextel Boost West LLC (Nextel), of Overland Park, Kansas. The underlying master Interconnection Agreement was previously approved by the Commission in Docket C-1946.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 31, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), on Citizens and Nextel entered into an agreement arrived at through voluntary negotiations. An executed copy of this amended Agreement is contained within the application.

Neither the Amendment nor any portion thereof, discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
