BY THE COMMISSION:

By application filed November 26, 2012, United Telephone Company of the West d/b/a CenturyLink ("CenturyLink"), of Denver, Colorado, seeks approval of an ICC Bill and Keep Amendment to the Commercial Mobile Radio Services Interconnection Agreement with AT&T Wireless Services, Inc. d/b/a AT&T Mobility LLC ("AT&T Mobility") of Atlanta, Georgia. The underlying master Interconnection Agreement was previously approved by the Commission in Docket C-2100.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 28, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and AT&T Mobility entered into an amended agreement arrived at through voluntary negotiations. An executed copy of this amended agreement is contained within the application.

Neither the Amendment nor any portion thereof, discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Amendment to the Interconnection Agreement between United Telephone Company of the West d/b/a CenturyLink, and AT&T Wireless Services, Inc. d/b/a AT&T Mobility LLC shall be, and it is hereby, approved.
