BY THE HEARING OFFICER:

On December 20, 2012, Total Call Mobile, Inc. ("Total Call" or "Applicant") filed an application seeking designation as an Eligible Telecommunications Carrier ("ETC") in the State of Nebraska for the limited purpose of participating in the Lifeline program. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on December 27, 2012. No protests or interventions were filed.

Planning Conference


O R D E R
