By application filed December 21, 2012, Qwest Corporation d/b/a CenturyLink QC of Denver, Colorado (CenturyLink), seeks approval of its Interconnection Agreement with Level 3 Communications, LLC, of Broomfield, Colorado (Level 3). Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 27, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
