BY THE COMMISSION:

By application filed January 4, 2013, United Telephone Company of the West d/b/a CenturyLink of Denver, Colorado (CenturyLink) seeks approval of a Master Resale Agreement with Spectrotel, Inc., of Neptune, New Jersey (Spectrotel). Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 8, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and Spectrotel entered into a Master Resale Agreement arrived at through voluntary negotiations. An executed copy of this agreement was contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the agreement should be approved.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement between United Telephone Company of the West d/b/a CenturyLink and Spectrotel, Inc. be, and it is hereby, approved.
