O P I N I O N     A N D     F I N D I N G S

On January 8, 2013, USCOC Nebraska/Kansas, LLC as successor in interest to WWC License L.L.C., ("USCOC") of Chicago, Illinois, filed an application seeking approval of Amendment 1 to its Wireless Interconnection and Reciprocal Compensation Agreement with Consolidated Telephone Company, ("Consolidated"), of Lincoln, Nebraska. The agreement amends the Interconnection Agreement previously approved in Docket C-3072. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 11, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On January 21, 2004, in Docket C-3072, the original interconnection agreement between USCOC and Consolidated was approved by the Commission. In the current application, USCOC seeks to amend the Agreement by adding Amendment 1 to the Wireless Interconnection and Reciprocal Compensation Agreement. An executed copy of the Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the Amendment should be approved.
