BY THE COMMISSION:

By application filed January 8, 2013, USCOC Nebraska/Kansas, LLC as successor in interest to WWC License L.L.C., ("USCOC") of Chicago, Illinois, seeks approval of Amendment 1 to its Interconnection Agreement with Southeast Nebraska Telephone Company, of Falls City, Nebraska (Southeast Nebraska Telephone). The underlying Interconnection Agreement was approved by the Commission in Docket C-3104. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 11, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), USCOC and Southeast Nebraska Telephone entered into Amendment 1 to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
