BY THE COMMISSION:

On January 17, 2013, a request was filed with the Nebraska Public Service Commission (Commission) by Nebraska Central Telephone Company (NCTC), Gibbon, Nebraska, seeking approval to update the boundaries of the Burwell Exchange of NCTC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 23, 2013. No protests were filed.

O P I N I O N A N D F I N D I N G S

NCTC is a local exchange carrier holding a certificate of public convenience and necessity to provide local exchange service in its respective territory. NCTC states that it has begun providing service at the request of customers now located in an area that had previously been unserved near the Burwell Exchange. NCTC has filed the request with the Commission to update the boundaries of the Burwell Exchange to reflect service by NCTC in the previously unserved area. NCTC provided an exchange map showing the area that it requests be added to the Burwell Exchange of its service territory. No other exchange carrier is offering service in the area sought to be added to the Burwell Exchange. As no other exchange carriers are affected by the requested change to the Burwell Exchange and no protests were filed, the Commission processes this application administratively and without a public hearing.

Changes of a local exchange territory are governed by *Neb. Rev. Stat.* §§ 86-135 to 86-138. As NCTC is only seeking to update the Burwell Exchange to reflect that it is providing service in a previously unserved area, and in light of the fact that no protests were filed by any party and no other exchange carriers will be affected by the boundary change, the Commission finds that the application is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4576 be, and it is hereby, granted.

IT IS FURTHER ORDERED that Nebraska Central Telephone Company submit a revised boundary map to the Commission within 30 days from the date of this order.


IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4576 be, and it is hereby, granted.
