### OPINION AND FINDINGS

January 30, 2013, Citizens Telecommunications Nebraska d/b/a Frontier Communications Company of Nebraska, ("Frontier") of Mound, Minnesota, filed application seeking approval of its an Amendment Interconnection Agreement with USCOC Nebraska/Kansas, LLC, ("USCOC") Chicago, Illinois. The agreement amends the Interconnection Agreement previously approved in Docket C-2896. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 1, 2013. were filed; therefore, this application is protests processed pursuant to the Commission's Rule of Modified Procedure.

On April 15, 2003, in Docket C-2896, the original Interconnection Agreement between Frontier and USCOC was approved by the Commission. In the current application, Frontier seeks to amend the Agreement by adding an Amendment to the Interconnection Agreement. An executed copy of the Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.
