O P I N I O N     A N D     F I N D I N G S

On January 30, 2013, Citizens Telecommunications Company of Nebraska d/b/a Frontier Communications of Nebraska, ("Frontier") of Mound, Minnesota, filed an application seeking approval of an Amendment to its Interconnection Agreement with United States Cellular Corporation, ("US Cellular") Chicago, Illinois. The agreement amends the Interconnection Agreement previously approved in Docket C-3315. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 1, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On January 11, 2005, in Docket C-3315, the original Interconnection Agreement between Frontier and US Cellular was approved by the Commission. In the current application, Frontier seeks to amend the Agreement by adding an Amendment to the Interconnection Agreement. An executed copy of the Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as

all applicable state laws. Using those standards, the Amendment should be approved.
