# BY THE COMMISSION:

## OPINION AND FINDINGS

On February 1, 2013, United Telephone Company of the West d/b/a CenturyLink ("CenturyLink") of Denver, Colorado, filed an application seeking approval of an ICC VoIP Amendment to the Interconnection Agreement with Communications Services, LLC (XO Communications) Herndon, Virginia. The underlying agreement was previously approved in Docket C-3082. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 7, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and XO Communications entered into an Amendment to their Interconnection Agreement through voluntary negotiations. An executed copy of the agreement is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Interconnection Agreement should be approved.
