OPINION AND FINDINGS

On March 7, 2013, Qwest Corporation d/b/a CenturyLink ("CenturyLink"), of OC Denver, Colorado filed application seeking approval of an ICC VoIP Amendment to its Interconnection Agreement with Neutral Tandem, Inc., ("Neutral Tandem") of Chicago, Illinois. The agreement amends the Interconnection Agreement previously approved in Docket C-4278. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 12, 2013. protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On July 13, 2010 in Docket C-4278, the original interconnection agreement between CenturyLink and Neutral Tandem was approved by the Commission. In the current application, CenturyLink seeks to add an ICC VoIP Amendment to the Interconnection Agreement. An executed copy of the Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Amendment to the Interconnection Agreement between Qwest Corporation d/b/a CenturyLink QC and Neutral Tandem, Inc. be, and it is hereby, approved.
