By application filed May 14, 2013, Aventure Communication Technology, LLC, of Sioux City, Iowa, is seeking authority to withdraw its certificate of authority to provide local exchange telecommunications services in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 16, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

On August 15, 2006, Aventure Communication Technology, LLC, was granted authority to provide local exchange telecommunications services within the State of Nebraska pursuant to Docket C-3614.

By application received on May 14, 2013, Aventure Communication Technology, LLC, requested the withdrawal of its authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska. Aventure Communication Technology, LLC, has no customers in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that the authority of Aventure Communication Technology, LLC, to provide local exchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4605 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity
