## O P I N I O N      A N D      F I N D I N G S

Norlight, Inc. is a corporation, organized under the laws of the State of Kentucky. Its principal place of business is Little Rock, Arkansas.

Norlight, Inc. is authorized to provide interexchange, IntraLATA and InterLATA telecommunications services in Nebraska pursuant to the Order issued by the Commission in Docket C-3891 on .

Norlight, Inc. requests that the Commission enter an order approving the name change to "Windstream Norlight, Inc." The entity has been registered with the Nebraska Secretary of State. This change in the name will have no affect on rates, terms, or conditions of service offered to Nebraska customers.

Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4609 be, and it is hereby, granted and the request of Norlight, Inc., to change its name to Windstream Norlight, Inc., be and it is hereby granted.
