O P I N I O N     A N D     F I N D I N G S

On June 25, 2013, Qwest Corporation d/b/a CenturyLink QC (CenturyLink), of Denver, Colorado, and Glenwood Telecommunications, Inc. (Glenwood), of Blue Hill, Nebraska, filed an application seeking approval of their Interconnection Agreement. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 1, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

CenturyLink and Glenwood seek approval of an Interconnection Agreement reached through voluntary negotiations. An executed copy of the Agreement is contained within the application.

The Agreement does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement between Qwest Corporation d/b/a CenturyLink QC and Glenwood Telecommunications, Inc. be, and it is hereby, approved.




