## BY THE COMMISSION:

On June 25, 2013, a joint application was filed by Windstream Nebraska, Inc. (Windstream), Little Rock, Arkansas, and Glenwood Telecommunications, Inc. (Glenwood), Blue Hill, Nebraska, seeking approval of the adoption of an Interconnection Agreement pursuant to 47 U.S.C. §252(i). Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on June 28, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Section 252(i) of the Telecommunications Act of 1996 allows any telecommunications carrier to adopt a Commission-approved Interconnection Agreement. Glenwood wishes to establish an Interconnection Agreement with Windstream and accordingly seeks to adopt the Nebraska Technology & Telecommunications, Inc. (NT&T) Interconnection Agreement. The NT&T and Windstream Agreement was approved by the Commission pursuant to Docket C-4572 on March 5, 2013.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Docket C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. Windstream and Glenwood have sufficiently complied with the procedures required by the Commission's policy.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4616 be, and it is hereby, approved and Windstream Nebraska, Inc. and Glenwood Telecommunications, Inc., are hereby authorized to adopt the Interconnection Agreement between Windstream Nebraska, Inc. and Nebraska Technology & Telecommunications.
