OPINION AND FINDINGS

On July 3, 2013, Qwest Corporation d/b/a CenturyLink QC ("CenturyLink"), of Denver, Colorado, filed an application seeking approval of an Interconnection Amendment with 365 Wireless, LLC ("365 Wireless"), of Atlanta, Georgia. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 11, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On August 20, 2013, in Docket C-4617, an Interconnection Agreement between CenturyLink and 365 Wireless was approved by the Commission. In the current application, CenturyLink and 365 Wireless seek to add a Four-Party Transit Traffic Amendment to the Interconnection Agreement. An executed copy of the Amendment is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
