OPINION AND FINDINGS

On August 9, 2013, Qwest Corporation d/b/a CenturyLink QC ("CenturyLink"), of Denver, Colorado, filed an application seeking approval of an Amendment to its Interconnection Agreement with Teleport Communications America, LLC f/k/a TCG Omaha, New York, New York ("Teleport"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 13, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

CenturyLink and TCG Omaha entered into an Interconnection Agreement reached through arbitration under Section 252(b) of the Telecommunications Act of 1996. Said agreement was approved by the Commission in Docket C-3095 on October 13, 2004. On August 9, 2013, CenturyLink and Teleport filed an Amendment to their Interconnection Agreement. The executed copy of the Agreement is contained within the application.

The Amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the Amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement Amendment between Qwest Corporation d/b/a CenturyLink QC and Teleport Communications America, LLC f/k/a TCG Omaha be, and it is hereby, approved.
