BY THE COMMISSION:

By application filed October 21, 2013, Go Solo Technologies, Inc. (Go Solo), of St. Petersburg, Florida, is seeking authority to withdraw its certificate of authority to operate as an interexchange carrier of telecommunications services within the State of Nebraska, previously approved in Docket C-2938. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 25, 2013. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On June 3, 2003, Go Solo was granted authority to operate as an interexchange carrier of telecommunications services within the State of Nebraska pursuant to Docket C-2938.

By application received on October 21, 2013, Go Solo requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Go Solo currently does not have any customers in the State of Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Go Solo's authority to provide resold interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4637 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Go Solo Technologies, Inc., is withdrawn.

IT IS FURTHER ORDERED that any interexchange tariff of Go Solo Technologies, Inc., be, and it is hereby, withdrawn.
