BY THE COMMISSION:

By application filed January 3, 2014, Entrix Telecom, Inc., (Entrix) Newark, New Jersey, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-2864. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 9, 2014. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

On February 19, 2003, Entrix was granted authority to provide interexchange telecommunications services within the state of Nebraska pursuant to the Commission's order entered in Docket C-2864.

By application received on January 13, 2014, Entrix requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Entrix has no customers or facilities in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Entrix's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4653 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Entrix Telecom, Inc., is cancelled.

IT IS FURTHER ORDERED that the interexchange tariff of Entrix Telecom, Inc. be, and is hereby, withdrawn.
