BY THE COMMISSION:

By application filed May 12, 2014, Telemanagement Systems, Inc., (TSI) Centennial, Colorado, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-2179. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 15, 2014. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On February 8, 2000, TSI was granted authority to provide interexchange telecommunications services within the state of Nebraska pursuant to Docket C-2179.

By application received on May 12, 2014, TSI requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. TSI has no customers or facilities in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that TSI's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4682 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Telemanagement Systems, Inc., is cancelled.

IT IS FURTHER ORDERED that any interexchange tariff of Telemanagement Systems, Inc. be, and is hereby, withdrawn.
