BY THE HEARING OFFICER:

On May 19, 2014, TAG Mobile, LLC (TAG Mobile) of Carrollton, Texas, filed an application seeking designation as a non-rural wireless Eligible Telecommunications Carrier for the purpose of receiving support from the federal Universal Service Fund and from the Nebraska Telephone Assistance Program (NTAP). Notice of the application appeared in the Daily Record, Omaha, Nebraska on May 23, 2014. On June 23, 2014, N.E. Colorado Cellular, Inc. d/b/a Viaero Wireless (Viaero) filed a Petition for Formal Intervention. On August 12, 2014, the Commission granted Viaero's Petition.

On August 26, 2014, a planning conference was held in Lincoln, Nebraska and via conference call. A Hearing Officer Order was entered on September 9, 2014, establishing the procedural schedule.

With the consent of all parties, I enter this Order to modify that procedural schedule. The revised procedural schedule is attached hereto as "Appendix A" and fully incorporated herein. The hearing will be continued from December 16, 2014 to **February 25, 2015**, at 1:30 p.m. in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska 68508.
