BY THE COMMISSION:

By application filed May 27, 2014, Cable USA III, LLC (Cable), Scottsbluff, Nebraska, is seeking authority to withdraw its certificates of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-4028.¹ Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 30, 2014. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On September 11, 2007, Cable was granted authority to provide local exchange and interexchange telecommunications services within the State of Nebraska pursuant to Docket C-4028.²

By application received on May 27, 2014, Cable requested the withdrawal of its authorities to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. Cable was sold in 2012 and has no customers or facilities in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Cable's authorities to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4687 be, and it is hereby, granted and the Certificates of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to Cable USA III, LLC, is cancelled.
