BY THE HEARING OFFICER:

On June 13, 2014, Q Link Wireless, LLC ("Q Link" or "Applicant") filed an application seeking designation as an Eligible Telecommunications Carrier ("ETC") in the State of Nebraska for the limited purpose of participating in the Lifeline program. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on June 18, 2014.

On July 17, 2014, N.E. Colorado Cellular, Inc., d/b/a Viaero Wireless ("Viaero") filed a Petition for Formal Intervention in the above-captioned docket.

A planning conference was held in the above-captioned docket on September 4, 2014, and a procedural schedule adopted including scheduling a hearing on January 20, 2015.

On October 2, 2014, Q Link filed a Motion for Continuance and sought a minimum thirty (30) day extension to all pending deadlines in the adopted procedural schedule, including the hearing. Q Link indicated in its Motion it had conferred with counsel for Viaero and there was no objection from Viaero to the extension as requested.

I therefore find that Q Link's Motion for Continuance should be granted and the procedural schedule deadlines for various events are hereby modified as set forth in Appendix A attached to this order and hereby incorporated by reference.

**Hearing**

I further find the hearing in Docket No. C-4690/NUSF-98 scheduled for January 20, 2015, be rescheduled to **Tuesday, February 24, 2015, at 1:30 p.m. CST** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska.
