By application filed August 18, 2014, United Telephone Company of the West d/b/a CenturyLink QC (CenturyLink) of Denver, Colorado, seeks approval of an Interconnection Agreement with New Horizon Communications Corporation (NHCC), Lexington, Massachusetts.
