BY THE HEARING OFFICER:

On October 16, 2014, an application was filed by Jerry and Kerri Sundburg, Kris and Renee Erickson and the Shoup Family Ltd. c/o Kim Shoup, Clarks, Nebraska, seeking a boundary change to receive telephone service from the adjacent exchange of Hordville from Hamilton Telephone Company ("Hamilton") in lieu of their current telephone service from the Central City Exchange of Qwest Corporation d/b/a CenturyLink QC ("CenturyLink"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 21, 2014.

Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application.

I issued an order on January 13, 2015, scheduling a hearing on **February 23, 2015**, in the Grand Island Public Library, 211 North Washington Street, Grand Island, Nebraska, with a video link to the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska.

On February 9, 2015, a Stipulated Agreement signed by Hamilton and CenturyLink was filed with the Commission. In the Stipulation the companies agree and consent to the boundary change requested in the above-captioned applications and waive the previously scheduled hearing.

Upon consideration of the stipulated agreement and being fully advised, the Hearing Officer finds the hearing previously scheduled on **February 23, 2015**, should be cancelled.
