BY THE COMMISSION:

By application filed October 20, 2014, Momentum Telecom, Inc., of Birmingham, Alabama, seeks to withdraw its authority to offer local exchange and interexchange telecommunications services and to cancel its tariffs in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 23, 2014. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

By virtue of the authority granted by the Commission in Docket C-3923, Momentum was given the ability to offer local exchange and interexchange telecommunications services within the State of Nebraska. In a letter received on October 17, 2014, Momentum requested the withdrawal of its Certificate of Public Convenience and Necessity and Tariffs within the State of Nebraska. Momentum does not have any local exchange or interexchange customers in the State of Nebraska. Momentum does offer Voice over Internet Protocol (VoIP) to customers in Nebraska and will be required to register that service with the Commission.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable and finds that Momentum's Certificate of Public Convenience and Necessity to offer telecommunications services and all applicable tariffs should be canceled.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4723 is hereby granted, and the Certificate of Public Convenience and Necessity granted to Momentum Telecom, Inc., to offer local exchange and interexchange services in Nebraska and all applicable tariffs are canceled.
