O P I N I O N     A N D     F I N D I N G S

EarthLink is an interexchange provider in Nebraska. In the present application, EarthLink requests that the Commission enter an order approving a name change from Business Telecom, Inc. d/b/a EarthLink Business III to Business Telecom, LLC d/b/a EarthLink Business III. EarthLink has received authority from the Secretary of State to use the new name. Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4730 be, and it is hereby, granted and the request of Business Telecom, Inc. d/b/a EarthLink Business III, to change its name to Business Telecom, LLC d/b/a EarthLink Business III, is approved.

IT IS FURTHER ORDERED that the Applicant file an updated tariff reflecting the change in name within 30 days of the date of this order.
