BY THE COMMISSION:

By application filed December 12, 2014, Victory Telecom, Inc. (VTI), Arlington, Texas, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-4504. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 17, 2014. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On September 18, 2012, VTI was granted authority to provide interexchange telecommunications services within the State of Nebraska pursuant to Docket C-4504.

By application received on December 12, 2014, VTI requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. VTI has no customers or facilities in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that VTI's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4732 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Victory Telecom, Inc., is cancelled.

IT IS FURTHER ORDERED that any interexchange tariff of Victory Telecom, Inc., be, and is hereby, withdrawn.
