## BY THE COMMISSION:

By application filed April 15, 2015, United Telephone Company of the West d/b/a CenturyLink (CenturyLink), of Denver, Colorado, seeks approval of a Commercial Mobile Radio Services (CMRS) Interconnection Agreement with New Cingular Wireless, PCS, LLC (New Cingular), Bedminster, New Jersey. Notice of the application was published in <a href="https://doi.org/10.1007/jhcs.2015">The Daily Record</a>, Omaha, Nebraska, on April 20, 2015. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and New Cingular entered into an Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.
