BY THE COMMISSION:

On June 29, 2015, TracFone Wireless, Inc. ("TracFone" or "Applicant") of Miami, Florida, filed an application with the Nebraska Public Service Commission ("Commission") seeking designation as an Eligible Telecommunications Carrier ("ETC") in the State of Nebraska for the limited purpose of participating in the Lifeline program. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on July 3, 2015.

On August 19, 2015, NE Colorado Cellular, Inc. d/b/a Viaero Wireless' ("Viaero") Petition for Formal Intervention was granted.

On August 28, 2015, the Hearing Officer granted TracFone's motion to hold the application in abeyance for ninety (90) days, or until November 28, 2105.

On November 24, 2015, TracFone filed a Motion to Withdraw Application for Designation as an Eligible Telecommunications Carrier without Prejudice. In support of its motion the Applicant stated that due to issues beyond its control, it is unable to provide the undivided attention to its application in Nebraska as it intended. Therefore, to avoid delays, TracFone requested leave to withdraw the application at this time and resubmit it at a future time.

Being fully advised in the premise, the Commission finds that the Motion should be granted and the application filed in the above-captioned proceeding dismissed. Application No. C-4773/NUSF-103
