BY THE COMMISSION:

By application filed July 10, 2015, Tri-M Communications, Inc. d/b/a TMC Communications (TMC) of Rochester, New York, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-2005. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 14, 2015. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

On March 30, 1999, TMC was granted authority to provide interexchange telecommunications services within the State of Nebraska pursuant to Docket C-2005.

By application received on July 10, 2015, TMC requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. TMC provided notice to its seven (7) Nebraska customers in March of 2015 via bill insert of its intention to exit the Nebraska IXC market and has no facilities in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that TMC's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4775 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Tri-M Communications, Inc. d/b/a TMC Communications, is cancelled.
