BY THE COMMISSION:

By application filed April 1, 2016, Americatel Corporation d/b/a Ametex d/b/a Startec ("Americatel"), Irving, Texas, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 6, 2016. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On January 2, 1998, Americatel was granted authority to provide interexchange telecommunications services within the State of Nebraska in to Docket C-1719.

On April 1, 2016, Americatel requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. Americatel has no facilities or customers in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Americatel's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariff withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4831 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Americatel Corporation is cancelled.
