On July 21, 2016, Qwest Corporation d/b/a CenturyLink QC, United Telephone Company of the West d/b/a CenturyLink and Dex Media, Inc., filed an application seeking a determination that Neb. Admin. Code, Title 291, Chap. 1, §019.91 et seq.; Title 291, Chap. 5, §002.22A and 010.09; Title 291, Chap. 10, §006.07A be clarified or waived entirely or partially to permit compliance by digitally published directories, including online, rather than traditional paper printing publication. On December 6, 2016, the Commission entered an Order granting the request to end saturation delivery and imposing certain notice requirements for consumers.

On December 16, 2016, Qwest Corporation, d/b/a CenturyLink QC, United Telephone Company of the Wet d/b/a CenturyLink (collectively "CenturyLink"), and Dex Media, Inc. ("Dex Media") (collectively referred to as the "Movants"), filed a Motion for Reconsideration of the Commission's Order. At issue are the notice requirements and the requirement to bring an application back before the Commission prior to the cessation of delivery upon request. In its Motion, the Movants requested a hearing to undertake a limited reconsideration and clarification of its Waiver Order.
