BY THE COMMISSION:

By application filed August 11, 2016, TNCI Operating Company, LLC (TNCI OpCo), Irving, Texas, is seeking authority to withdraw its certificates of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-4601. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 15, 2016. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On May 14, 2013, TNCI OpCo was granted authority to provide local exchange and interexchange telecommunications services within the State of Nebraska pursuant to Docket C-4601.

By application received on August 11, 2016, TNCI OpCo requested the withdrawal of its authorities to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. TNCI OpCo has no facilities or customers in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that TNCI OpCo's authorities to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4864 be, and it is hereby, granted and the Certificates of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to TNCI Operating Company, LLC, are cancelled.
