BY THE COMMISSION:

By application filed December 20, 2016, ALEC, Inc. (ALEC), Nashville, Tennessee, is seeking authority to withdraw its certificates of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3967. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 23, 2016. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On December 16, 2008, ALEC was granted authority to provide local exchange and interexchange telecommunications services within the State of Nebraska pursuant to Docket C-3967.

By application received on December 20, 2016, ALEC requested the withdrawal of its authorities to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. ALEC has no facilities or customers in Nebraska and provides no telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that ALEC's authorities to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4883 be, and it is hereby, granted and the Certificates of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to ALEC, Inc., are cancelled.
