BY THE COMMISSION:

On May 26, 2017, a joint application was filed by Derrick Parr, Jeanette Parr, and Kim Herringer, ("Applicants") of Juniata, Nebraska, seeking a boundary change to receive advanced telecommunications capability service from the adjacent Blue Hill Exchange of the Glenwood Telephone Membership Corporation ("Glenwood") as the Kenesaw and Juniata Exchanges of Windstream (Windstream) are not currently providing service to these customers. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 8, 2017.

O P I N I O N A N D F I N D I N G S

Glenwood and Windstream are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. The Applicants resides within the boundaries of Windstream's Kenesaw or Juniata Exchanges, and have requested a boundary change so the Applicants may receive advanced telecommunications capability service from the Blue Hill Exchange of Glenwood. Windstream has notified the Commission that it does not oppose the proposed boundary change.

Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application. With no protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, the Commission processes this application administratively and without a public hearing.

Commission staff has modified the relevant exchange maps to show the boundary changes to the Kenesaw, Juniata, and Blue Hill Exchanges. Copies of the exchange maps with the proposed revisions are attached as Appendix "A" to this Order and hereby incorporated by reference. If either Glenwood or Windstream have objections or changes to the proposed boundary maps, they have until August 15,

2017, to contact the Commission with said objections or changes. If the Commission receives no objections or changes from either party by August 15, 2017, the boundary maps shall be modified as proposed in Appendix "A".

The Commission finds that, in light of the consent between the parties involved, the application is in the public interest and should be granted. It is the expectation of the Commission that the two carriers involved in the boundary change shall collaborate in good faith to ensure that the transition of the customer's service from one carrier to the other shall be as seamless as possible.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4933 be, and it is hereby, granted.

IT IS FURTHER ORDERED that on or before August 15, 2017, Glenwood Telephone Membership Corporation and Windstream Nebraska, Inc. shall contact the Commission with any changes or concerns regarding the boundaries as proposed in Appendix "A" to this Order. If no objection is received from either company, the boundaries as shown in Appendix "A" to this order shall be the official boundaries of Glenwood Telephone Membership Corporation and Windstream Nebraska, Inc.

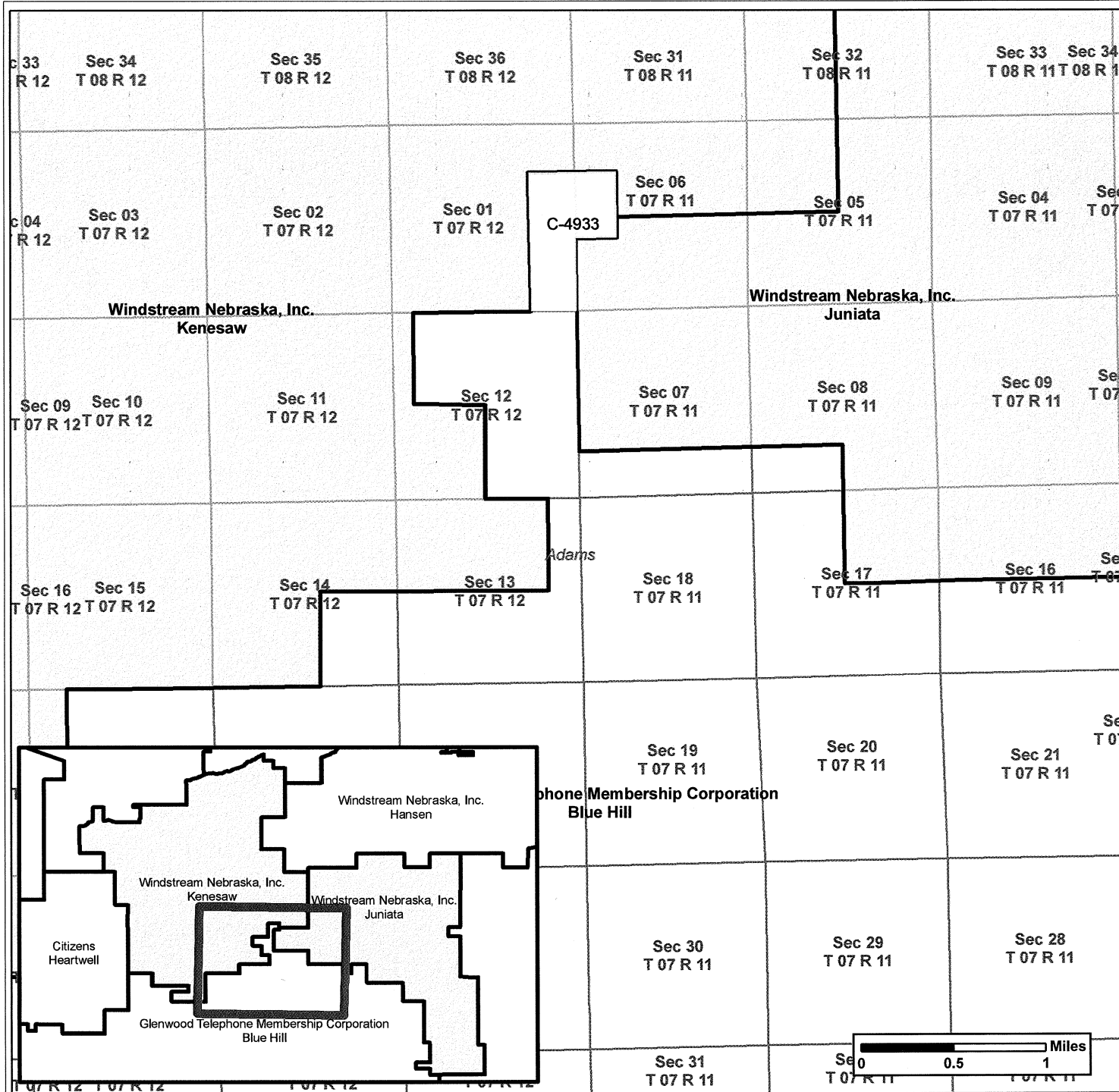

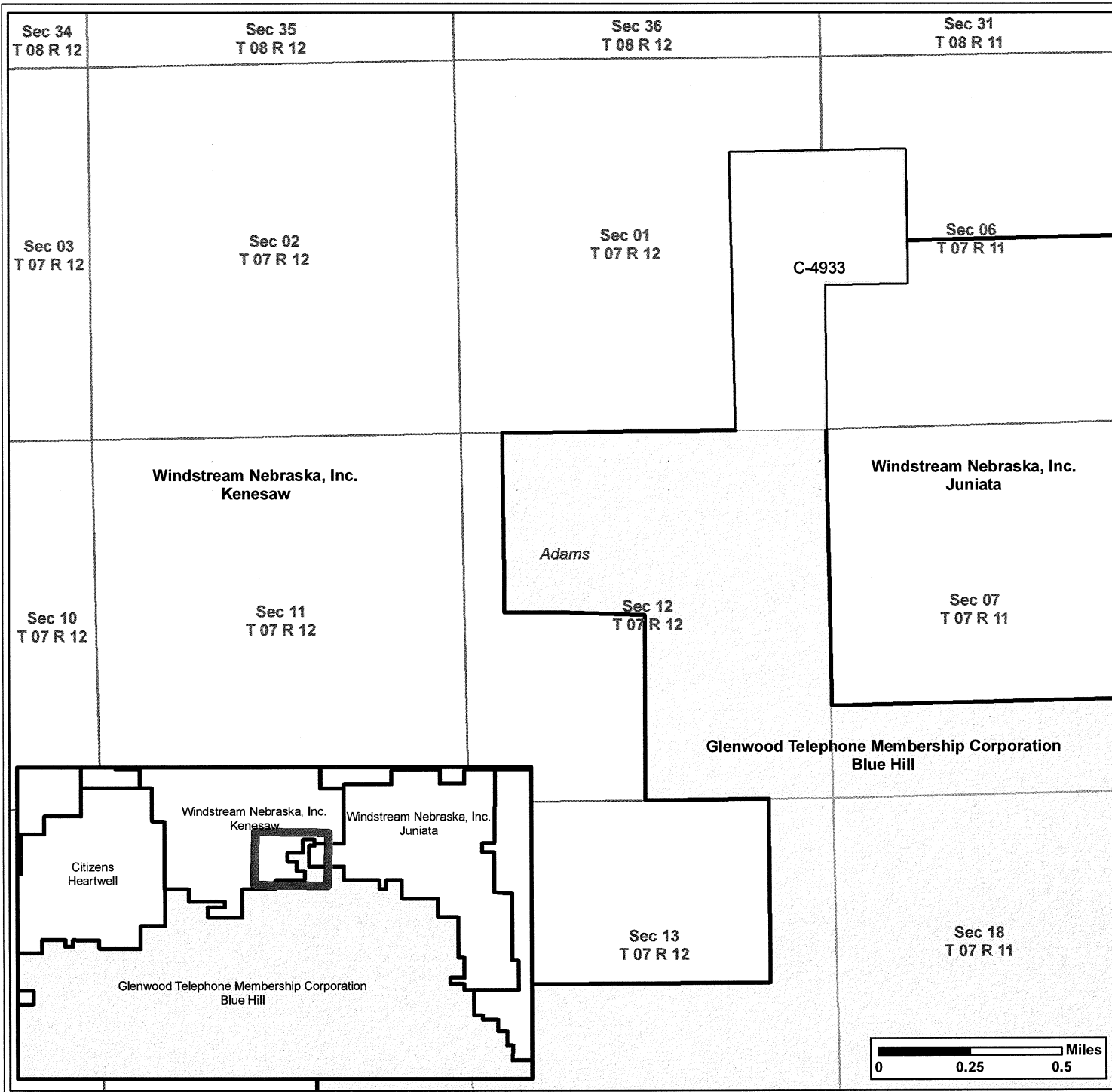
