By application filed September 1, 2017, Qwest Corporation d/b/a CenturyLink QC (CenturyLink), of Denver, Colorado, seeks approval of an ILEC-CLEC Mid-Span Meet POI Amendment to the Interconnection Agreement with Midstates Data Transport, LLC (Midstates Data), of Blair, Nebraska, previously approved in Docket C-4936. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 7, 2017. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and Midstates Data entered into a Mid-Span Meet POI Amendment arrived at through voluntary negotiations. An executed copy of this amendment is contained within the application.
