By application filed February 16, 2018, Qwest Corporation d/b/a CenturyLink QC (Qwest), of Denver, Colorado, seeks approval of an Interconnection Agreement with Matrix Telecom, LLC d/b/a Matrix Business Technologies d/b/a Trinsic Communications (Matrix). Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 23, 2018. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the federal Telecommunications Act of 1996 (the Act), 47 U.S.C. 252, Qwest and Matrix entered into an Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.
