BY THE COMMISSION:

On March 2, 2018, an application was filed by Keith Skrdlant, of Doniphan, Nebraska, seeking authority to change the exchange boundary to receive advanced telecommunications service from the Doniphan Exchange of Hamilton Telephone Company in lieu of service from Windstream, Inc. of Nebraska (Windstream). Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 6, 2018.

Hamilton notified the Commission it would consent to the boundary change. Windstream notified the Commission it would not consent to the boundary change as it intended to deploy broadband and serve applicants "within a reasonable time." An order scheduling this matter for hearing was issued May 16, 2018, and notice was provided to all interested parties. Hearing was held at the Doniphan Area Event Center on June 20, 2018.

On July 10, 2018, the Commission entered an order granting Mr. Skrdlant's Application. On July 20, 2018, Windstream filed a Motion for Rehearing and Request for Oral Argument.

Pursuant to Commission Rules of Procedure, 291 NAC Ch. 1, § 021.02A, the Commission shall allow Oral Arguments on Motions for Reconsideration, if requested. Each party shall have twenty (20) minutes in which to present arguments to the Commission regarding the outstanding Motion. Arguments shall be confined to the issues contained in the outstanding Motion. Further, each party may reserve some of its allotted twenty (20) minutes for rebuttal if it so desires.

Accordingly, the Commission hereby schedules an oral argument on the Motion for Rehearing. Arguments shall be heard on **August 14, 2018, at 2:00 p.m.**, central time, in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska 68508.
