## BY THE COMMISSION:

By application filed May 29, 2018, Charter Fiberlink-Nebraska, LLC ("Charter"), Atlanta, Georgia is seeking approval of an Interconnection Agreement for EAS Traffic Exchange Agreement with Breda Telephone Corporation (Breda), Breda, Iowa. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on June 5, 2018. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Charter and Breda entered into an Interconnection Agreement for EAS Traffic Exchange Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review service agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the service agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement for EAS Traffic Exchange Agreement between Charter Fiberlink-Nebraska, LLC, Atlanta, Georgia, and Breda Telephone Corporation, Breda, Iowa, be, and it is hereby, approved.
