By Application filed October 9, 2018, Business Telecom, LLC, d/b/a EarthLink Business III ("EarthLink"), Little Rock, Arkansas, requests cancellation of its authority to operate as an interexchange carrier of telecommunications services and to cancel its tariffs in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 12, 2018. No protests or interventions were filed; therefore, this application is being processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

By virtue of the authority granted by the Commission in Docket C-1245, EarthLink was given the ability to offer interexchange telecommunications services within the State of Nebraska. In an application received on October 9, 2018, EarthLink requested the cancellation of its Certificate of Public Convenience and Necessity and Tariffs within the State of Nebraska. The Certification, relating to EarthLink providing resold interexchange telecommunications services in the State of Nebraska, is no longer necessary because the Company no longer wishes to provide those services.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable and finds that EarthLink's Certificate of Public Convenience and Necessity to offer telecommunications services and all applicable tariffs should be cancelled.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-5011 is hereby granted, and the Certificate of Public Convenience and Necessity granted to Business Telecom, LLC, d/b/a EarthLink Business III, Little Rock,
