By application filed October 10, 2018, Inventive Wireless of Nebraska, LLC d/b/a Vistabeam ("Vistabeam" or "Applicant") of Gering, Nebraska, seeks designation as an Eligible Telecommunications Carrier for the purpose of providing services supported by the FCC's Connect America Fund Phase II.
