By application filed February 14, 2019, Qwest Corporation d/b/a CenturyLink QC ("CenturyLink"), of Denver, Colorado, seeks approval of a Reciprocal Compensation Bill and Keep Amendment to the Interconnection Agreement with Level 3 Communications, LLC, of Broomfield, Colorado ("Level 3 Communications"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 2, 2018. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

The underlying agreement was approved by the Commission in Docket No. C-2780. Pursuant to 47 U.S.C. § 252(a) of the Telecommunications Act of 1996 ("the Act"), CenturyLink and Level 3 Communications entered into a Reciprocal Compensation Bill and Keep Amendment to their underlying Interconnection Agreement. An executed copy of this amendment is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment should be approved.
