BY THE HEARING OFFICER:

On February 27, 2009, a Formal Complaint was filed with the Nebraska Public Service Commission ("Commission") by Orbitcom, Inc., ("Orbitcom") Sioux Falls, South Dakota, seeking a determination that AT&T Communications of the Midwest, Inc., ("AT&T") Denver, Colorado, failed to pay intrastate access charges billed by Orbitcom in accordance with Orbitcom's intrastate switched access tariff. That Formal Complaint was docketed by the Commission as Application No. FC-1332. On April 30, 2009, AT&T filed the above-captioned Formal Complaint against OrbitCom with the Commission, that was docketed as Application No. FC-1335. On May 1, 2009, AT&T filed a Motion to Consolidate the above-captioned proceedings pursuant to Commission Rules of Procedure, the motion was granted by the Commission in an order issued on May 12, 2009.

Planning Conference

A planning conference was held in the above-captioned dockets on June 11, 2009, at 1:30 p.m. in the Commission Niobrara Conference Room, 300 The Atrium, 1200 N Street, Lincoln; Nebraska, and via telephone conference with representatives of the Parties and the Commission. Participating via telephone, for AT&T, Melanie McIntyre, Wauneta Browne, and Victor Liss; and for the Commission, Commissioner Tim Schram.

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.
