On July 14, 2010, a Formal Complaint was filed with the Nebraska Public Service Commission ("Commission") by U.S. Chicory, Inc., ("Complainant") Scottsbluff, Nebraska against SourceGas Distribution LLC, ("SourceGas" or "Respondent") Lakewood, Colorado alleging billing inaccuracies. An Answer was timely filed by SourceGas.
