BY THE HEARING OFFICER:

On September 17, 2010, a Formal Complaint was filed with the Nebraska Public Service Commission ("Commission") by Great Plains Communications, Inc. and Great Plains Broadband, Inc., (collectively "Great Plains") against Sprint Communications Company, L.P., ("Sprint") and was docketed as Application No. FC-1346. An Answer was timely filed by Sprint.

On November 8, 2010, Sprint filed a Formal Complaint against Great Plains with the Commission that was docketed as Application No. FC-1347. An Answer was timely filed by Great Plains.

On December 13, 2010, both Great Plains and Sprint filed Motions to Compel responses to discovery requests in the above-captioned docket. Both parties requested a hearing on the motions.

The Hearing Officer finds that oral arguments on the Motions to Compel shall be scheduled for **Tuesday, December 14, 2010, immediately following the adjournment of the 10:00 a.m. weekly Commission meeting** in the Commission Hearing Room at 300 The Atrium, 1200 N Street, Lincoln, Nebraska. Parties wishing to argue shall be prepared to provide information as to how the discovery requests at issue are or are not reasonably calculated

to lead to the discovery of admissible evidence within the scope of the above-captioned docket.

O R D E R

IT IS THEREFORE ORDERED by the Hearing Officer that oral arguments on Great Plains Communications, Inc. and Great Plains Broadband, Inc. and Sprint Communications Company, L.P.'s Motions to Compel shall be scheduled for **Tuesday, December 14, 2010, immediately following the adjournment of the 10:00 a.m. weekly Commission** in the Commission Hearing Room at 300 The Atrium, 1200 N Street, Lincoln, Nebraska.
