BY THE HEARING OFFICER:

On September 17, 2010, a Formal Complaint was filed with the Nebraska Public Service Commission ("Commission") by Great Plains Communications, Inc. and Great Plains Broadband, Inc., (collectively "Great Plains") of Blair, Nebraska, against Sprint Communications Company, L.P.,("Sprint") located in Overland Park, Kansas. An Answer was timely filed by Sprint. That Formal Complaint was docketed by the Commission as Application No. FC-1346.

On November 8, 2010, Sprint filed a Formal Complaint against Great Plains with the Commission. The Commission docketed the Sprint Formal Complaint as Application No. FC-1347. An Answer was timely filed by Great Plains.

On November 8, 2010, Sprint filed a Motion to Consolidate the above-captioned proceedings pursuant to Commission Rules of Procedure. The motion was granted by the Hearing Officer in an order issued on November 10, 2010.

Planning Conference

A planning conference was held in the above-captioned docket on November 16, 2010, at 1:30 p.m. in the Commission Niobrara Conference Room, 300 The Atrium, 1200 N Street, Lincoln; Nebraska, and via telephone conference with

representatives of the Parties. The following persons were present at the conference: for Sprint, Loel P. Brooks of Brooks, Pansing Brooks, PC, LLO; for Great Plains, Paul M. Schudel of Woods & Aitken LLP; and for the Commission, Nichole Mulcahy, Legal Counsel for the Commission and Commissioner Frank E. Landis. Participating via telephone, for Sprint, Diane C. Browning and William Bret Lawson; and for Great Plains, Thomas J. Moorman.
