BY THE HEARING OFFICER:

On February 4, 2011, a Formal Complaint was filed with the Nebraska Public Service Commission ("Commission") by Hartington Telecommunications Company, Inc., Hartington, Nebraska, ("Complainant") against AT&T Communications of the Midwest, Inc. ("AT&T"), Denver, Colorado, alleging failure by AT&T to pay for intrastate access services provided by the Complainant. AT&T timely filed an answer in the above-captioned complaint.

On March 1, 2011, AT&T filed a Motion to Dismiss the above-captioned complaint and requested oral argument on the motion.

I issued an order on March 2, 2011, setting oral arguments on April 5, 2011 and a briefing schedule prior to the arguments. Both parties have now requested the arguments be rescheduled due to conflicts of schedule.


