By Petition filed June 1, 2012, N.E. Colorado Cellular Inc. d/b/a Viaero Wireless (Viaero), sought support from the Nebraska Universal Service Fund (NUSF) dedicated wireless program. Notice of the application appeared in the <u>Daily Record</u>, Omaha, Nebraska on June 7, 2012. The Commission allocated \$5 million for the 2011 NUSF calendar funding year in which this Petition was filed. On July 6, 2012, United States Cellular Corporation (US Cellular) filed a Petition seeking Formal Intervention. The Petition of Formal Intervention was granted by the Commission on July 17, 2012.

A public hearing on the application was held on December 4, 2012, in Lincoln, Nebraska in conjunction with Docket No. NUSF-69.11. On January 15, 2013, the Commission granted the application, in part, approving funding for the following ten tower sites: Chadron South, Ellsworth North, Grant South, Harrisburg West, Harrison North, Keystone, Laurel North, Mullen North, Rushville North, and Wayne South in an amount totaling \$3,703,984 or the actual cost of construction for the ten sites. The remaining requested tower sites received no funding, as the Commission's allocation of \$5 million for dedicated wireless program support for the 2012 calendar year was exhausted.

Viaero subsequently notified the Commission that it was unable to secure land for the **Ellsworth North** tower at the exact location described in its Petition. On April 30, 2014, Viaero requested support for an alternative site near the Ellsworth North tower site. On August 1, 2014, Viaero and the Nebraska Telecommunications Infrastructure and Public Safety Department (Department) entered into a stipulated agreement whereby Viaero agreed that, in exchange for the Department's support of the modification Viaero would not seek or receive additional support

from the Program for the 2012 year, other than the funding amounts originally awarded.

OPINION AND FINDINGS

After receiving Viaero's request, the Commission the the alternative tower location using methodology adopted by the Commission in its previous findings in dedicated wireless fund orders in the 2012 funding year. The Commission staff then determined the alternative site eligible for and would have received dedicated wireless fund support. Subsequently, the NTIPs Department and Viaero entered into the August 1, 2014 stipulation whereby Viaero and the NTIPS Department agreed that the support amount would not be changed as a result of this modification. In consideration of specific circumstances presented in this case, the Commission is of the opinion and finds the stipulated agreement between the NTIPS Department and Viaero should be approved. The Commission further finds Viaero's request for support of the alternative tower site should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the stipulation between the NTIPS Department and N.E. Colorado Cellular, Inc. d/b/a Viaero Wireless be and it is hereby approved.

IT IS FURTHER ORDERED that the modification request filed by N.E. Colorado Cellular Inc. d/b/a Viaero Wireless shall be and it is hereby granted as provided herein.
